

#### **Art. 1 DISCIPLINES AND DISTANCES**

The world championship takes place in two shots disciplines:

#### **RIFLE COMPETITION:**

50 m on a "running target" to wild boar silhouette (four silhouettes for 5 shots);

100 m four standing targets from four positions (four silhouettes for 5 shots);

200 m from the shots from bench to the chamois shape (two silhouettes for 5 shots);

300 m from the shots from bench to the deer shape (two silhouettes for 5 shots).

#### **SMOOTH-BORE COMPETITION**

"COMBINED" Shots Ball with smooth-bore weapons on fixed and mobile silhouette: two series of 16 shots each, total 32 shots. Thus divided:

50 mt on a "moving target" wild boar silhouette (two rounds of two silhouettes for 4 shots);

50 mt on a "fixed target" boar shape (two rounds of two silhouettes for 4 shots.

#### Art. 2 Second "BRUNO MODUGNO" TROPHY

The second Bruno MODUGNO Trophy will take place with the following specialties

- Rifle

50 mt on a "moving target" wild boar silhouette (four silhouettes for 5 shots);

- Smooth Bore:

50 mt on a "moving target" wild boar silhouette (four silhouettes for 4 shots);

NB: The classification of the Trophy will be derived from the sum of points scored by the individual participants in the World Championship, from the above specified specialties.

## **Art. 3 PARTICIPANTS - REQUIREMENTS**

All Italian shooters, or who have participated in FIDASC OPEN National Championships), who are in possession of a valid FIDASC card, can participate (receipt stating the payment for the current year).

All members of the Associations. Safari Club and the "CNDA" National Consortium of Archibugieri, Blaser Club with FIDASC membership.

Furthermore, all foreign shooters in possession of accident insurance and RCT can participate, or members of a Nationale Federation.

Shooters belonging to the Juniores (minors) category can participate in the Federal competition, provided they are in possession of the indemnity form (completed and signed by the parents at the time of the annual registration to the FIDASC) which must be shown in copy at the time of presentation on the field.

It should be noted that junior shooters not in possession of a PDA, the responsibility of the firearm remains with the person who is entrusted with it (Coach, instructor, etc.) who temporarily entrusts the firearm in the time strictly necessary for the session. shooting range, the responsibility on the shooting lines is delegated to the technician / shooting director / match official.

All shooters must complete the required registration form, declaring that they are in possession of any valid firearm license as specified by the current rules in Italy.

#### **Art. 4 CATEGORIES**

- Junior man and lady: aged between 16 and 20 years;
- Senior: aged between 21 and 64 years;
- Veterans: aged between 65 onwards with no age limit;
- Lady: from 21 onwards with no age limit.

NB: The age will be calculated by competition and birth year without actual birth date.

#### Atr. 5 REGISTRATIONS - TITLES - AWARDS SIGNING UP:

#### **Art. 6 REGISTRATIONS**

The registration fee is € 20.00. Free for Lades, Juniors and foreign teams. The fee will be paid to the organizing association

#### Art. 7 AWARDS:

The national FIDASC will provide the prizes, as specified below:

- a) Medals, crests, cups and diplomas for the podiums of all categories;
- b) Cash refunds of the prize money of € 10,000.00 as distributed below;
- c) Lottery Prizes given by the sponsors ( € 10.000 APPROXIMATELY);
- d) Bruno Modugno Trophy.

#### Art. 8 TITLES:

They will be proclaimed WORLD CHAMPIONS C.I.T.S.C. "FIDASC":

- Rifle shooting champion: the best athlete classified in the required tests "COMPLETE" (summing up the score of the tests in the specialties 50, 100, 200 and 300 m max 600 pts);
- Smooth bore champion: the best athlete classified in the required tests "COMBINED" (by adding up the score of the tests to the specialties of the "Fixed and Mobile" targets max 320 pts).

They will be proclaimed C.I.T.S.C. WORLD CHAMPIONS "FIDASC" COUPLE OF GENDER, the couples enrolled MAN & LADY in the Disciplines of reference. The Gender Pair classification is determined by the sum of the scores achieved by the components that form it, these scores are derived from the results obtained on the series targets scheduled in the individual competitions of the registered specialties. Each nation can register multiple Gender Couples.

It will be proclaimed WORLD CHAMPION, "the team" first classified in the specialties of reference. Each nation can register multiple teams.

Teams are made up of members of the same nation, teams must be made up of four shooters, or a minimum of three shooters. These teams can also be composed in mixed form between the different categories. The composition must be declared in writing at the time of registration by filling out the required form, and subsequently it CANNOT be changed for any reason. Shooters can only participate for one team. The best three results will be counted for the final classification. The Italian representative team will be composed as required by the FIDASC Federal regulations.

#### Art. 9 REFUNDS

## The cash prizes will be divided as follows for both Disciplines:

- €. 300.00 cd in favor of the first classified in each category;
- €. 200.00 cd in favor of the second in each category;
- €. 150.00 cd in favor of the third in each category;
- €. 100.00 cd in favor of the fourth in each category;
- €. 50.00 cd in favor of the fifth in each category;

#### **GENDER COUPLE:**

- 1st class. €. 300.00, 2nd class. €. 200.00, 3rd class. €. 100.00;

#### **WORLD CHAMPION TEAM:**

- €. 400.00;

### **ABSOLUTE CHAMPION:**

- €. 250.00.

#### **Art. 10 COMPETITION ORGANIZATION**

The system is set up with two shots ranges in different locations.

- Field "A" Mobile wild Boar Silhouette 50 m;
- Field "B" Lines 100 200 300 m.

     Shots at 50 mt running wild boar target;

Shots at 100 m on 4 fixed targets, silhouettes of roe deer, sitting fox, chamois and wild boar.

- 18 September 2022:
  - 08:00 am Field "A" "SMOOTH BORE COMPETITION"

Shots at two standing targets and two running targets;

• 08:00 am Field "B" RIFLE COMPETITION"

Shots at 200 m on a fixed target with a chamois silhouette and shots at 300 m on a fixed target with a deer silhouette.

#### Art. 11 TRAINING

The organizing structure guarantees, in the days before the competition, the possibility of carrying out test shots on the targets provided in the various categories and weapons calibration.

Alle shooters have to check their weapons and weight them with the scale available at the shooting range.

#### **Art. 12 SECURITY RULES**

The shooter must present himself on the shots line with earphones, or similar, and with protective goggles, with the rifle in safety and in perfect operating conditions, with ammunition suitable and for the number required by the regulations of the individual Disciplines. It is forbidden for the shooter to carry a greater number of cartridges than those strictly necessary to carry out the test.

The shooter must be present on the lines as required by the reference batteries, at least half an hour before his own test. When called, he shows up on the firing line with shotgun in case, when he does not fire the weapon must in any case be in safety, with the bolt in the rear position (even semi-automatic rifles). The Official in charge will call the shooters to the firing line. After the 3rd call and as required by the regulations, the shooter not present will be sanctioned with exclusion from the competition.

#### **Art. 13 FEDERAL DELEGATE**

The Delegate represents the C.I.T.S.C. in federal events, he has no organizational duties, although he is the <u>supervisor</u> of the event for its best outcome. The Delegate has the power to adopt, in the spirit of the regulations, all the measures necessary in the interest of the smooth running of the event, overseeing the regularity and strict compliance with federal provisions and the Regulations of the various Disciplines. Report to the JURY and / or to the C.I.T.S.C./ FIDASC Competitors who, with words, acts or other manifestations, present an incorrect and / or disrespectful / polemical behavior towards the Officials, Executives and / or other competitors. He receives any complaints that may be presented on the field by the competitors and, in the case of application of federal regulations and regulations, having heard the opinion of the Coordinator of the College of Match Officials, decides, and reports the decision to the Jury. If no solution is found, the complaint must be presented as an "APPEAL" to the JURY.

Other complaints / appeals made outside the times or in the manner provided for in this regulation will not be taken into consideration.

The delegate is in charge of gun control according to the relevant regulations.

#### Art. 14 OFFICIAL COORDINATOR OF THE COMPETITION

The Officials Coordinator is appointed by the C.I.T.S.C.

The Coordinator is the head of the judging panel, manages the Race Officials in their duties and roles, as well as receives and manages any complaints presented to the Delegate. The Coordinator has the right to adopt, in the spirit of the regulations, all the measures deemed necessary in the interest of the smooth running of the event, supervising the regularity and strict observance of the federal and program regulations. Report to the Delegate and the Jury, those competitors who, with words, acts or other

manifestations, behave incorrectly or at least disrespectfully towards the race officials, managers, members of the organizing committee or other competitors. Manages, with the Delegate, any complaints that may be presented on the field by the competitors and, in the case of application of federal regulations and regulations, after hearing the opinion of the reference match official, informs the Jury by sending all the documents for the adoption of any measures. The Coordinator or his delegate will sign all the silhouettes before the test is performed.

#### Art. 15 OFFICIALS

The Match Officials are chosen from among those enrolled in the Register of Federal Match Officials. The C.I.T.S.C. it has the right to also appoint foreign officials who are not present in the national registers. The officials have no organizational tasks in any way, they are designated based on the number of shots lines set up for the competition, and the number of participants. The official has the right to order security manipulations on firearms at any time. The official checks and is responsible for the quantity of cartridges allowed on the firing station for the performance of the test. It also ensures that no one goes beyond the limit admitted to spectators. Report to the Delegate or Coordinator of the Race Officials those competitors who, with words, acts or other manifestations, behave incorrectly or at least disrespectfully towards the Officials, the Organizing Committee or other competitors. He also reports to the Officials Coordinator any behavioral non-compliance with reference to the regulatory and procedural provisions of these regulations. The occurrence of actions dictated above, the shooter is immediately disqualified and removed from the shots range by the Delegate or the Match Officials Coordinator, who also informs the Jury.

#### Art. 16 ASSISTANTS

The assistants are the responsibility of the ASD hosting the event, in the number agreed with the C.I.T.S.C. They are responsible for the proper functioning of the shots lines, for the positioning and replacement of the silhouettes used.

#### Atr. 17 JURY

The Jury is reported by the C.I.T.S.C. and appointed by FIDASC The Jury has the task of making a definitive decision in any controversy or technical or behavioral appeal presented by the Delegate, which occurred during the event, as well as taking all those actions for a successful event. The Jury is in office from 08.00 on 16/07/2022 until 24.00 on 18/07/2022 or in any case when the event ends. The judgment of the jury cannot be appealed, complaints / appeals made outside the times will not be taken into consideration.

#### **Art. 18 BEHAVIORAL RULES**

It is strictly forbidden for shooters participating in the competition to interfere and influence in any way, during and after the event, the work of the Delegate and the Match Officials. The view of the targets is allowed only to the interested shooter, in the case of juniors with the delegated guardian, all in a strictly necessary time without interfering, influencing or manipulating the targets. It is absolutely forbidden for shooters to participate in events under the influence of drugs, alcohol and other similar, or in any case with an unsuitable psycho-physical state. The shooter, for any dispute, can make use of the provisions of the following point. In the event of irregularities in behavior, the competitor is immediately disqualified and removed from the shots range by the Delegate or Match Officials Coordinator who will immediately notify the Jury.

#### Art. 19 COMPLAINTS AND APPEALS

Any <u>complaints</u> must be received by the Delegate before or during the event, or in any case no later than the official rankings. <u>The Appeal</u> must be presented to the Jury before the official classification of the rankings, written and accompanied by a caution deposit of €. 100,00. In the case of acceptance of the appeal, the amount of €. 100.00 will be returned, otherwise it will be held. <u>The rankings will be declared official 45 minutes after their posting or publication on digital systems, the posting or publication time will make faith.</u>

#### **Art. 20 COMPETITION DISCIPLINES**

SUMMARY OF THE REGULATIONS OF THE DISCIPLINES

It should be noted that for anything that is not established here you have to refer to the regulations of the individual FIDASC specialties, which can be consulted on the website www.fidasc.it in the entry regulations for the year 2021.

#### Art. 21 SMOOTH BORE COMPETITION

NUMBER OF TARGETS - CALIBER - TYPE OF WEAPON - CARTRIDGE

The competition will take place in two series of 16 shots each one, totaling 32 shots.

Each series consists of four targets, each shooter will make a series of four targets on Saturday and one on Sunday, the series is composed as follows:

two 4 + 4-shot targets on a "mobile" boar silhouette target;

two targets of 4 + 4 shots on a "fixed" target.

"Mobile" Target Shots:

All shots must be fired to moving siluette that is in window 10 mt. The target is running from right to left and from left to right with constant speed so that it is visible 2,5-2,8 s. Target will be running by shooter command. The target line must be formed by a 10m window, where is about half of the distance a 1 m wide wooden screen, plywood or similarAt "READY" the shooter assumes the position as shown in Figure n. 1 to the regulations of the FIDASC Discipline, under the command - "READY GO", he takes up the weapon and must take a shot at each appearance of the target. At the end of the first 2-shot run, the shooting is continued until the end of series (4 shots) Maximum shooting time for serie is 2 minutes. Shots not fired or finished on guards and bulkheads are considered void and cannot be repeated. The match official, present on the shots line, must absolutely enforce the time necessary to carry out the reloading of the shots provided for each series, as well as guarantee maximum safety, avoiding the shooter making any movement that could affect the safeguarding of own and others' safety. In full compliance with the above, the shooter, if desired, can also swing his weapon between one shot and the next.

By entering to shooting position and from that, shooter should carry the weapon n the way it is visible that it's not loaded and is not allowed to direct barrel(s) to horizontal position (except in shooting window)

### Shots at the "fixed" target:

The competition takes place on the same parameters as the moving target shots, with the difference that all shots are fired on a fixed target. The so-called "Olympic" posture is also allowed. The use of rigid jackets (TSN model) is prohibited.

It is allowed to swing the rifle at each shot and view the pyro shots on the targets with their own optical systems (e.g. binoculars, monoculars), always in compliance with the safety rules dictated by the match official and respecting the time set for execution of the test. At the end of the time, at the command "ALT", the competitor immediately suspends the shot by unloading the weapon. Any shots fired after the ALT involve the cancellation of as many valid shots starting from those of greater value.

#### Arms and Caliber:

In all competitions, the use of smooth-bore, non-radius weapons is allowed. Juxtaposed, overlapping or semi-automatic 12 or 20 gauge, loaded with cartridges with a maximum weight of gr. 28 with a tolerance of 2%, (28.56 g) excluding the "BORRAGE" if separated. The use of a shotgun is prohibited.

It is absolutely forbidden to change weapons, the four silhouettes must be carried out with a single shotgun. The only exception is if the weapon in use ceases to function and for reasons ascertained by the Match Officials Coordinator. Shooters must present themselves on the firing line with an extra cartridge, which at the discretion and sample can be collected by the match official present on the firing line for the necessary checks.

The shooter is solely responsible for assembling his own ammunition, both in terms of regulations and in terms of safety, relieving the entire organization from any non-compliance, as well as damage caused to himself, to others or to property. "Magnum" or "semi magnum" ammunition is prohibited. Weapons are allowed metal (rear sight and front sight). The rear sight must have an internal opening angle of no more than 180 degrees. Modifications to stock and fore-end (barrel cover) are also allowed, for example: adjustable stock, anatomic, etc. Any other precaution deemed inappropriate by the match official and / or optical device is prohibited. The Match Official present on the shots line ensures strict compliance with the obligation to use headphones or other hearing protection systems and the use of protective goggles, regularly positioned.

The shooter will sign their silhouettes at the time of scoring.

# Art. 22 RIFLE COMPETITION (50-100-200-300)METERS:

Shots specialty at 50m on mobile boar silhouette (maximum weight of the weapon 5,100 kg):

The competition takes place in 4 rounds of 5 strokes each. Having taken his place on the stand, the competitor proceeds, on the command of the Race Official, who is obligatorily present, to load the firearm with ONE cartridges of the permitted type. The target of the running boar will be fired at a distance of 50 meters. alternately from left to right and from right to left or vice versa, in a shots window of 10 meters. The speed will be adjusted to allow shooter to see the target for about 2.5 to 2.8 seconds both left to right and vice versa. The shooter waiting for the target can take up the weapon after calling the same without waiting for its appearance. Each run must be completed in a maximum time of 5 minutes.

# Shots specialty at 100mt on 4 positions (maximum weight of the weapon 5,100 kg)::

The competition takes place in 4 rounds of 5 shots per shape:

N.5 shots to the ROE: the shooter will be in an upright position with the weapon resting on the side of a pole (the kick must be <u>placed</u> sideways to the pole and not frontally), placed on one side of the station, with a diameter of 8/15 cm fixed and well stable;

N.5 shots SITTING FOX: the shooter will be lying on the ground, his arms supporting the front part of the rifle, resting only on the elbows;

N.5 shots CHAMOIS: the shooter will be in an upright position with the weapon resting on one side of the stick, alpenstok, with a diameter of 25/30 mm and a height of 2 mt. approximately, which must only be placed to the ground;

N.5 shots BOAR: the shooter will be in an upright position without any support.

All shots will be taken from their respective positions at a distance of 100 meters. Academic shots are allowed.

Each target must be completed in a maximum time of 5 minutes, it can be overall time for all 4 target 20 min.

<u>Shots specialties at 200m on a chamois shape (maximum weight of the weapon 5,400 kg)</u>: The competition takes place in 2 rounds of 5 hits each. Each heat must be completed in a

The target of the chamois will be fired at a distance of 200 meters, with bipod mandatory, (rear support provided by the organization). Each shooter will have 2 sighting shots available ONLY in the first silhouette (mandatory).

### Shots specialty at 300m on a deer shape (maximum weight of the weapon 5,400 kg):

The competition takes place in 2 rounds of 5 hits each. Each heat must be completed in a maximum time of 5 minutes.

The deer target will be fired at a distance of 300 meters. with bipod mandatory, (rear support provided by the organization). Each shooter will have 2 sighting shots available ONLY in the first silhouette (mandatory).

#### OPTICAL WEAPONS AMMUNITION AND CLOTHING

Scopes without limitations;

maximum time of 5 minutes.

Only TWO weapons are allowed to perform all disciplines, (closed actions not allowed); Calibers from .222 rem upwards;

Ammunition commercial or reloaded.

Rigid shooting jacket or heavy clothing (not allowed).

Shots not fired in good time, or after the ALT, or ended on the guards and bulkheads, or rebounding or in any case where an anomaly is perceived (ex. Ogives sideways) are considered null and cannot be repeated.

#### Art. 23 COMPETENCES OF THE C.I.T.S.C.

To make corrections or changes to the official regulations, or to the progress of the program, by virtue of special or emergency needs.

NB: For all that is not included in this regulation, reference is made to the regulations of the FIDASC federal disciplines for the current year.
