AIMS

Within the framework of its institutional scope(art. 2 of the Statutes), FIDASC organises its 1st individual Open European Cup, from 50, 100 and 200 meters

ORGANISATION

The competition has been organised by F.I.D.A.S.C. nazionale in cooperation with Associazione Sportiva Dilettantistica "La Vescovada", able to assure the development of the competition in compliance with the shooting event requirements set for in this Regulation.

PARTICIPANTS - CONDITIONS

All shooters having a valid FIDASC card (receipt proving the payment for the current year) may participate; Moreover, all foreign shooters declaring under their own responsibility, to have an accident insurance and an RCT (third party responsibility) insurance may participate as well; all foreign shooters with no insurance, wishing to participate, shall fill in the ad hoc document and pay the sum € 25,00, which will allow them to be covered by the insurance signed by FIDASC;

In the "Junior" category, shooters between 16 and 20 years of age, with no gun licence, may participate in the competition on condition that they will be accompanied by a person fulfilling the requirements set for in the regulations into force.

CATEGORIES

The following categories are included

- Senior : between 21 and 60 years of age
- Veterans : over 60 years of age
- Ladies : from 21 years of age on with no age limit
- Junior men and ladies : between 16 and 20 years of age

The registered age is to be considered with respect to the solar year of the period in which the competition takes place.

(**) - Ranking resulting from the sum of the results obtained in the three specialty events

ENTRY APPLICATIONS – TITLES – PRIZES

Entry applications to the competition must arrive to the organisation headquarter at least 20 days before the beginning of the event.

Three separate rankings will be drawn up for the three different specialty events.

FIDASC nazionale will provide for the following prizes:

a) CUPS, medals, crests and diplomas for the first three places of all categories and specialty events;b) Prize money.

The FIRST EUROPEAN CUP of shooting with rifle will be awarded to the best ranked shooter of the three events included in the "COMPLETE" (the winner will be identified by adding up the score of the trials of the three disciplines: 50, 100 and 200 meters.).

The prize money amounts to \notin 10,000.00 divided as it follows:

- € 300.00 to each one of the first ranked shooters of each category and specialty;
- € 200.00 to each one of the second ranked shooters of each category and specialty;
- € 150.00 to each one of the third ranked shooters of each category and specialty;
- 14 "reserved" prizes of € 100,00 to be distributed to each one of the best ranked shooters of each category and specialty according to the number of participants.

- 6 "reserved" prizes of € 50.00 for the not awarded junior shooters.

- € 500.00 reimbursement to the winner of the "Complete" (the winner is identified by adding up the scores obtained in the three specialty events).

The awarded shooters shall collect the prizes, if they do not, the prizes will be withdrawn by FIDASC and will no more be handed to the interested shooter.

The registration fee is € 25.00 per specialty event (Ladies and Juniors excluded).

DEVELOPMENT OF THE COMPETITION

The competition will take place in two days:

- a) 1st day: 50 m. running boar and 200m fixed chamois;
- b) 2nd day: 100 m. 4 fixed targets, i.e. Deer, Sitting fox, Chamois and Boar;

Each shooter will perform two rounds per specialty;

The shooter shall present him/herself at the firing line with headphones or similar hearing protection devices and protection eyeglasses, with the rifle in perfect functioning conditions and suitable ammunitions. All shooters are strictly forbidden to bring with them more cartridges than those strictly needed to end the competition.

When called, the competitor shall present at the firing line with his/her rifle in its case, when the shooter doesn't shoot, the rifle must always remain open with the bolt in the backward position (semi-automatic rifle);

The Competition Judge will call the shooters on the firing line. After the 3rd call, the absent shooter will be disqualified.

Specialty event: 50 m running boar:

The competition is performed in two rounds of four shots each; for each round 2 shots are fired to the target from left to right and 2 shots, from right to left. The shooting sequence is decided by the shooter.

Once at the stand, the shooter, upon command of the Competition Judge who must be there, proceeds to load the rifle with one allowed cartridge;

The running boar will be shot from a distance of 45 to 50 meters, from left to right and from right to left alternatively in a shooting window of 10 meters.

The speed will be regulated to make it possible to see the target for about 2.5 seconds both from left to right and from right to left.

The shooter waiting for the target may shoulder the rifle after calling the target without waiting for it to show.

All shots will be fired from the respective stands.

Specialty event: Four 100 m targets:

The competition takes place in two rounds of 16 shots each. Each round includes:

n. 4 shots on the DEER: the shooter will stand with the rifle resting on a pole set aside the stand, having a diameter of 8/15 cm , and the two ends fixed (ground/ceiling);

n. 4 shots at the SITTING FOX: the shooter will lie down in the prone position, his arms will support the rifle only with the elbows;

n. 4 shots at the CHAMOIS: the shooter may stand with the rifle resting on an alpenstok having a diameter of 25/30 mm and 2 m high, fixed to the ground;

n. 4 shots at the BOAR: the shooter will stand with no support at all.

All shots will be fired from the shooters' respective stands from a distance of 100 meters.

The academic shot is allowed.

Depending on the installations, the first trial will be performed on the deer, the second on the sitting fox, the third on the chamois and the forth on the boar, and so on for all the participants who will keep rotating by occupying the different stands.

In full respect of the target sequence, when it is possible, it is allowed to place them not to have the same target for all shooters

Specialty event: 200 m chamois:

The competition takes place in two rounds of four shots each. Each round must be ended in 8 minutes maximum.

The chamois will be shot from 200 meters with the support provided by the organization. All shots will be performed from each one's stand.

TRAININGS

According to the Event calendar, shooters may train in the days before the competition with no shooting limits at training targets.

TARGETS

The used targets are those mentioned in the attachment a) of this regulation; for the 100 m shooting, 70x100 targets will be used; for the 200 m shooting 50x70 targets will be used; for the running boar shooting a 70x50 target will be used.

WEAPONS, SIGHTINGS AND AMMUNITIONS

Hunting rifles figuring in the manufacturers' catalogues are allowed.

Weapons shall have a fixed, non-adjustable stock (example: stock length and cheek support height) and the forestock shall not be higher than the original trigger guard. Stocks may be replaced provided the above conditions are observed. "Thumbhole" stocks are allowed. Moreover, both "Bedding" and customized trigger sensitivity as well as the stecker use is allowed .

It is absolutely forbidden the use of any kind of tripod or other support: No prototype is allowed. Mouth brakes are allowed as well as the use of one-single shot weapons.

Allowed calibers are those provided in article 13 paragraph 1 law 157/92, but no lesser than caliber 222 Remington.

Sights: sights with variable magnifying lens with no limits are allowed.

The whole weapon (telescope, magazine and bolt) shall weigh no more than 5,000 grams and its total length shall not be more than 125 cm.

The use by shooters of other telescopes to verify the fired shot is allowed.

Semi-automatic (hunting) rifles are allowed.

All shooters are obliged to make available the rifle used for the competition if Judges so require for the compliance control;

All ammunitions, including re-charged ammunitions are allowed. Shooters using re-charged cartridges must declare it when they register for the competition. Armored bullets are forbidden.

FIRED SHOT CHECK

If a shooter fires five shots at the same target, only four shots will be considered valid and the best score will be excluded.

If "A" shooter fires at "B" target of the nearby shooter, he cannot fire another shot at his/her target and only the three shots fired at the target of "A" shooter will be considered. To evaluate the score of "B" shooter (five shots at his/her target) the following method will be applied: if the identification of the shot fired by "A" shooter is possible (different caliber, different hole), this shot will be cancelled; if the identification is not possible (same hole diameter), the best four shots of "B" shooter will be considered and the worst shot will be cancelled.

PLAY-OFFS

In case of tie for the first three places of each specialty event, the related play offs will be carried out over a full round of free hand boar shooting .

JUDGES COODINATOR

The Judges Coordinator is selected from among FIDASC Judges, entered on the Federation Register.

The Judges Coordinator has the faculty of adopting , in the spirit of the regulation, all measures he/she deems necessary in the interest of the good running of the Event; he/she overlooks at its regularity and the strict observance of the regulatory provisions set for by the Federation and the Program.

He/she reports to the Jury those shooters who in words, acts or other expressions, behave unfairly or at least disrespectfully vis à vis the Judges, the Directors, the members of the Organizing Committee or other shooters.

He/she receives the possible complaints submitted on the ground by the competitors and, if the Federation regulations and provisions apply, after hearing the opinion of the judge in charge, informs the Jury by handing them all the relevant documents in view of the adoption of the possible measures.

He/she decides the participation with reserve of the shooters in whose regards a complaint has been submitted which cannot be immediately solved.

JUDGES

The Judges are selected from among those registered on the Federal Judge Register.

The Judges are appointed according to the number of the firing lines prepared for the development of the competition and the number of participants.

At any moment the Judges may order safety manipulations on the weapons.

The Competition Judge controls the number of cartridges allowed on the firing stand to carry out the trial. He/she also controls that nobody trespasses the spectator's barriers .

He/she reports to the Judges Coordinator those shooters, who in words, acts or other expressions, behave unfairly or at least disrespectfully vis à vis the Judges, the Directors, the members of the Organizing Committee or other shooters

He/she also reports to the Competition Officials Coordinator behavioral infringements of the regulatory and procedural provisions set for in this regulation.

When the above conditions occur, the shooter is immediately disqualified and accompanied out of the shooting ground by the Judges Coordinator, who also informs the Jury.

ASSISTANTS

Assistants are in charge of the good running of the firing lines, the placement and the replacement of the used targets.

JURY

The Jury shall decide for any dispute and technical or behavioral complaint occurring during the competition.

RULES OF BEHAVIOUR

Shooters participating in the competition are strictly forbidden to interfere with and/or influence in any way, during and after the trial, the work of FIDASC Delegate and the Judges'.


For any controversy, the shooter may avail him/herself of the provisions set for in the next article of this regulation.

In case of irregular behavior, the shooter is immediately disqualified and accompanied out of the shooting ground by the Judge who will immediately inform the Jury.

COMPLAINTS

Complaints must be submitted in written form before reading the official rankings, after paying a caution money of 50 Euros, which will be refunded only in case the claim is admitted by FIDASC Delegate . If not, the above sum of 50 Euros will be held by FIDASC.
